

The Neighborhood Christian Clinic is a 501(c)(3) non-profit medical and dental clinic located in central Phoenix that opened for patient care in 1999. Organized by a group of staff and volunteer healthcare professionals, we exist simply to:

1. provide medical and dental healthcare services to the uninsured, underserved community
2. share the Gospel and love of Jesus Christ with interested patients and colleagues, and
3. train & equip healthcare professionals to respectfully share the Gospel & love of Jesus Christ in their daily practice.

There are approximately one million people in Phoenix neighborhoods who do not have the means to obtain primary or specialty medical and dental care. Each year the clinic performs **thousands of medical and dental visits**; dispenses medications; provides comprehensive laboratory testing and ultrasound examinations; offers low-cost referrals to radiology centers for basic x-ray and barium studies as well as to our volunteer network of over fifty sub-specialists; provides comprehensive diabetic care; maintains on-site clinics in dermatology, gynecology, chiropractic, infectious disease, neurosurgery, pulmonary and psychiatric care.




Volunteers & Donations Needed

Because of the volunteer efforts of many healthcare professionals, interpreters, and financial donations of others, we are able to provide all of these necessary services at minimal cost to the patient.

However, the pressing demand for patient care greatly exceeds the current capacity of the clinic. The hard fact is that **daily we are forced to turn away families and individuals seeking care**. Volunteers are needed to help staff the clinic for additional hours and to see more patients.

Most people are unaware of the fact that the state of Arizona permits taxpayers to redirect a portion of their tax dollars to a qualifying charity, thus allowing gifts to charitable organizations out of tax dollars, at no cost to the donor.

- Current Arizona tax code allows for charitable donations of up to \$800 for married taxpayers filing jointly and up to \$400 per taxpayer filing as single to be **redirected to a qualifying charity** and returned to the taxpayer not as a deduction but as a credit!
- This means that taxpayers filing in Arizona may redirect a portion of their state tax dollars to charitable channels at **no additional financial cost** to themselves!
- With approximately one million people living in Phoenix neighborhoods who have no means to obtain primary or specialty medical or dental care, this is a **benefit** each taxpayer should take advantage of.
