

A Note from the Medical Director

Looking back on my first visit with Mario five years ago, I really didn't expect him to do well. In contrast to the typical hardworking, energetic male patients I usually see, Mario was unmarried, 28 years old and living with his mother. He had recently been verbally abusive towards her, and his social worker had insisted that he come to our clinic. The list of psychiatric medicines he was taking explained his dull, expressionless appearance. The agreement was simple. I would help him with his general medical needs, and he would continue to see his psychologist and psychiatrist through the state sponsored program that also provided his psychiatric medications. He accepted prayer prior to leaving the clinic that day.

As the years went by, Mario lived up to my expectations in many ways—in the odd jobs he took, and the unemployment between those stints, in the smoking habit, and later the methamphetamine addiction and the inpatient stays in rehabilitation programs that followed. Once during a psychotic delusion, he swung his fist violently towards a voice that taunted him, lacerating his hand. Mario stopped attending church, ashamed of his addiction and his life.

During one of his many visits, in addition to our time spent in prayer, I had shared the gospel with Mario. I hadn't seen any response. Shortly afterwards, Mario came in suffering from depression. His grandfather had died,

and Mario told me that he had been a Christian. We prayed some more.

Last week, our friend returned. He had relapsed again on crystal meth, and had just completed another stay in rehab. His face appeared tired, and his eyes were half shut from the combined effects of multiple psychiatric medications and fatigue. We caught up on his medical care, and then I asked him how he was doing.

He surprised me when he said, "You know, doc, I have these demons." Realizing that these may be more than hallucinations, I asked him what he did to respond to the demons. With eyes now clear and open, he said, "I pray to Jehovah God in the name of Jesus Christ." I was in awe. He went on to say that he was learning about prayer and had been seeking God. He said he had been experiencing an eagerness to learn more about God, and a new hope for his future.

As we closed our visit, as usual, I offered to pray. Mario was eager for prayer, but asked if he could be the one that led the prayer. I wish I could describe for you the amazement I felt as this hardened, scarred outcast prayed an honest, heartfelt prayer to Jesus.

Mario is rising above my expectations, because God is drawing him into a trusting relationship. Please pray that our Lord continues to work through the clinic to bring his children back to himself.

Healthcare "Reform"

We are certainly in the midst of interesting economic times coupled with intense polarization on healthcare. Because the Clinic provides healthcare to the uninsured working poor, we are often asked what affect healthcare reform will have on the Clinic. Our only response can be "we don't know" because we don't know all the nuances of the healthcare bill that just passed.

Nor do we know the outcome of the petitions of appeal many, many states have or intend to file. We do know that in early March, Arizona legislature budget cuts ended a healthcare program for 47,000 low income children and removed 310,000 working poor adults from state funded healthcare. The result is that now more than 20% of Arizona residents do not have health insurance and actual healthcare reform takes effect in 2014.

We also know that Christ told us the poor and needy will always be with us and for us to have compassion on them. By the grace of God, the Clinic compassionately provides healthcare for the needy while sharing the Truth of the Gospel.

We are grateful to all who are part of the Clinic's ministry – through volunteer as well as financial support. Each is an equally critical component. Without one or the other, Christ-centered, compassionate care could not be delivered.
