THE CLINIC PROVIDES PRIMARY AND ACUTE CARE TO PATIENTS WITHOUT MEDICAL INSURANCE. IN 2024, THE CLINIC HAD APPROXIMATELY 9,061 MEDICAL AND DENTAL VISITS THROUGH THE CLINIC'S STAFF AND VOUNTEER EFFORTS OF HEALTHCARE PROFESSIONALS AND INTERPRETERS. DONATED SERVICES RECEIVED DURING 2024 TOTALED 9,012 HOURS FOR DENTAL, MEDICAL AND TRANSLATION SERVICES THAT WERE PERFORMED BY INDIVIDUALS WITH SKILLS THAT WOULD OTHERWISE BE PURCHASED BY THE CLINIC. THESE SERVICES WERE VALUED AT \$351,878. AS A PART OF PATIENT CARE, THE CLINIC PROVIDES PHARMACEUTICALS TO PATIENTS AT A GREATLY REDUCED PRICE. DURING 2024, THE CLINIC RECEIVED DONATED PHARMACEUTICALS VALUED AT \$2,477,642.
